A quorum was declared by the Chairman and the meeting was called to order. Inquiry of the General Public present

Chairman Scull asked if any members of the general public wished to speak. No members of the general public were in attendance.

Board Member Conflict of Interest and Inquiry of Conflicts of Interest

Mr. Templeton asked if any Board Members had a Conflict of Interest with any of the current meeting agenda items. No conflicts were submitted.

Officer's and Director's Insurance

Mr. Templeton and Mr. Ambach reviewed the D&O history of having \$5 million coverage. It was discovered by the Office of Risk Management that the amount of current coverage is \$1 million.

Mr. Ambach explained an additional \$4 million of coverage would cost an additional \$51,337 annually through RSUI (rated A+ XIII Superior by AM Best) insurance beginning as soon as possible. Approval of the January 5, 2023 Special Meeting Minutes

The Chairman asked for consideration of the minutes for the January 5, 2023 special meeting. Mr. Scull asked for an update of the IRS exam of Sanford Health 2015 bonds. Mr. Templeton explained that Sanford Health replied to the Exam questions and has not heard back yet. Mr. Templeton added that Westhills Village Series 2017 bonds are under an IRS Exam as well.
