#### Good Samaritan Society Series 2013 Bonds

The bonds fund 50 twin homes, 42 congregate living units, 32 assisted living units for a bond amount not to exceed \$28.5 million for the South Dakota projects. Dan Bacastow reviewed the approving resolution to hold the TEFRA meeting. *(see Attachment #2)*. Mack Wyly moved to approve the resolution with additional property addresses revised per Dan Bacastows explanation and Dave Timpe seconded. # RESOLUTION OF THE SOUTH DAKOTA HEALTH AND EDUCATIONAL FACILITIES AUTHORITY CALLING FOR A PUBLIC HEARING ON AN ISSUE OF REVENUE BONDS ON BEHALF OF THE EVANGELICAL LUTHERAN GOOD SAMARITAN SOCIETY

BE IT RESOLVED by the South Dakota Health and Educational Facilities Authority (the "Authority"), as follows:

- The Evangelical Lutheran Good Samaritan Society (the "Society"), has advised the Authority of its desire (i) to finance and refinance the cost of the acquisition, construction, improvement and equipping of certain skilled nursing facility and other health care, assisted living and senior living facility improvements in various locations outside of the State of South Dakota, (ii) to finance the acquisition, construction, improvement and equipping of an assisted living facility, senior apartments and related infrastructure, including, but not limited to up to approximately 50 twinhomes, approximately 42 housing with services apartments, and an approximately 32-bed assisted living community at the Good Samaritan Society-St. Martin Village, to be located at 1304 through 1765 City Springs Road, 4929 through 4950 Grace Way, 4808 through 4965 Good Shepherd Way and 4964 through 4905 Jericho Way, all in Rapid City, South Dakota 57702, in the case of the twinhomes, at 4811 St. Martin Drive, Rapid City, South Dakota 57702, in the case of the assisted living facilities, and at 4825 Jericho Way, Rapid City, South Dakota 57702, in the case of the senior housing and independent living facilities (collectively the "South Dakota Project"), owned, managed and operated by the Society, (iii) to establish a reserve fund for the hereinafter referred to Bonds, and (iv) to pay certain costs of issuing the Bonds, all through the issuance by the Colorado Health Facilities Authority (the "Colorado Authority") of its Health Facilities Revenue Bonds (The Evangelical Lutheran Good Samaritan Society Project), Series 2013 (the "Bonds"), in a principal amount not to exceed \$115,000,000, of which an amount not to exceed \$28,500,000 will be applied to finance the South Dakota Project and certain related costs described above.
- 2. The Authority will not issue the Bonds, nor will the Authority or the State of South Dakota have any liability with respect to the Bonds or the sale or offering thereof. The public hearing and any subsequent action, if any, taken by the Authority is solely for purposes of Section 147(f) of the Internal Revenue Code of 1986, as amended (the "Code"), in compliance with Section 1-16A-15.1 of the South Dakota Codified Laws. The Authority has not reviewed, passed upon, or approved, and will not review, pass upon or approve, among other matters: (i) the financial feasibility of the plan of finance related to the Bonds, (ii) the feasibility or advisability of the financing of the South Dakota Project, (iii) the adequacy or operations of the South Dakota Project to be financed with the proceeds of the Bonds or (iv) the validity, credit or feasibility of the Bonds or the status of interest on the Bonds themselves, nor has the Authority approved or passed upon, nor will the Authority approve or pass upon, the sufficiency of any official statement or other offering document with respect to the Bonds.
- 3. Since a portion of the facilities proposed to be financed by the Bonds are to be located in South Dakota, Section 147(f) of the Code, and regulations promulgated thereunder, requires that prior to the issuance of the Bonds, the Authority and the Governor of

the State of South Dakota approve the use of proceeds of the Bonds finance the South Dakota Project, after conducting a public hearing thereon. Section 1-16A-15.1 of the South Dakota Codified Laws requires that the Authority determine whether the financing by the Colorado Authority should proceed with respect to the financing of the South Dakota Project and requires the approval of the Governor of the State of South Dakota pursuant to Section 147(f) of the Code. A public hearing on the proposal to issue the Bonds to finance the South Dakota Project is hereby called and shall be held on a convenient date as is selected by the Executive Director of the Authority to allow sufficient time for publication of the notice of the public hearing in the manner required by law. The Authority will receive a fee, to be paid by the Society, of \$10,000 for calling and conducting the public hearing and obtaining the necessary approvals under Section 147(f) of the Code for the State of South Dakota, and Jones Day, Bond Counsel to the Authority, and Murphy, Goldammer & Prendergast, L.L.P., Counsel to the Authority, will each separately be paid, by the Society, for its respective time charges and expenses in connection with the review and preparation of certain materials required for the South Dakota portion of the financing under Section 147(f) of the Code and Section 1-16A-15.1 of the South Dakota Codified Laws.

4. The Executive Director of the Authority is hereby authorized and directed to cause notice of the public hearing, in substantially the form attached hereto as *Exhibit A*, to be published once in the <u>Daily Capital Journal</u> and once in the <u>Rapid City Journal</u>, each publication to be not less than 14 days prior to the date fixed by the Executive Director for the public hearing.

## NOTICE OF PUBLIC HEARING CONCERNING THE ISSUANCE OF BONDS ON BEHALF OF THE EVANGELICAL LUTHERAN GOOD SAMARITAN SOCIETY

NOTICE IS HEREBY GIVEN that the South Dakota Health and Educational Facilities Authority (the "South Dakota Authority") will conduct a public hearing concerning the approval of the issuance by the Colorado Health Facilities Authority (the "Colorado Authority") of its Health Facilities Revenue Bonds (The Evangelical Lutheran Good Samaritan Society Project) Series 2013 (the "Bonds") on behalf of The Evangelical Lutheran Good Samaritan Society (the "Society"). Under this plan of finance, the Bonds will be issued in an aggregate principal amount not to exceed \$115,000,000. A portion of the Bond proceeds in an amount not to exceed \$28,500,000 will be used to finance the acquisition, construction, improvement and equipping of an assisted living facility, senior apartments and related infrastructure, including, but not limited to up to approximately 50 twinhomes, approximately 42 housing with services apartments, and an approximately 32-bed assisted living community at the Good Samaritan Society—St. Martin Village, to be located at 1304 through 1765 City Springs Road, 4929 through 4950 Grace Way, 4808 through 4965 Good Shepherd Way and 4964 through 4905 Jericho Way, all in Rapid City, South Dakota 57702, in the case of the twinhomes, at 4811 St. Martin Drive, Rapid City, South Dakota 57702, in the case of the assisted living facilities, and at 4825 Jericho Way, Rapid City, South Dakota 57702, in the case of the senior housing and independent living facilities (collectively the "South Dakota Project"). The remainder of the proceeds of the Bonds will be used to (i) finance and refinance the cost of the acquisition, construction, improvement and equipping of certain skilled nursing facility and other health care and senior living facility improvements in various locations outside of the State of South Dakota, (ii) refund certain outstanding bonds of the Society which financed capital projects outside of the State of South Dakota, (iii) establish a reserve fund for the Bonds, and (iv) pay certain costs of issuing the Bonds.

The Bonds will constitute special limited obligations of the Colorado Authority payable solely from amounts received by the Colorado Authority pursuant to a loan agreement between the Colorado Authority and the Society, the principal owner, operator and manager of the South Dakota Project. The South Dakota Authority will not issue the Bonds, nor will the South Dakota Authority or the State of South Dakota have any liability with respect to the Bonds or the sale or offering thereof. The public hearing and any subsequent action, if any, taken by the South Dakota Authority is solely for purposes of Section 147(f) of the Internal Revenue Code of 1986, as amended (the "Code"), in compliance with Section 1-16A-15.1 of the South Dakota Codified Laws. The South Dakota Authority has not reviewed, passed upon, or approved, and will not review, pass upon or approve, among other matters: (i) the financial feasibility of the plan of finance described in this notice, (ii) the feasibility or advisability of the financing of the South Dakota Project, (iii) the adequacy or operations of the South Dakota Project financed with the proceeds of the Bonds or (iv) the validity, credit or feasibility of the Bonds or the status of interest on the Bonds themselves, nor will the South Dakota Authority approve or pass upon, the sufficiency of any official statement or other offering document with respect to the Bonds.

All interested parties are invited to present comments at the public hearing regarding the issuance of the Bonds and the use of the proceeds thereof. The public hearing is required by Section 147(f) of the Code, and Section 1-16A-15.1 of the South Dakota Codified Laws.
